Pricing/Shipping Details/Insurance:

Australian Orders must be paid by direct bank deposit, Credit card, cheque, or money order.

No products will be shipped until full payment has cleared to Yuri 4x4 Pty Ltd.

No shipments will be forwarded C.O.D.

Prices are listed as a guide and are subject to change without notice.

All prices are in Australian Dollars (AUD) but do not include freight unless indicated.

For Custom-built products it is necessary to contact Yuri 4x4 Pty Ltd staff to confirm a price.

The freight and packaging is not included in the sale price. Yuri 4x4 can arrange freight on your behalf.
